STOP LEAKS AND CONTAIN SPILL. REMOVE AS MUCH AS POSSIBLE AND PLACE IN A SEALED CONTAINER.

NEUTRALIZE REMAINING TRACES WITH DILUTE ACID. THEN FLUSH AREA WITH WATER AND COVER WITH LIBERAL AMOUNTS OF SODIUM BICARBONATE
